The Plan is sponsored and administered by the Board of Trustees. The Trustees have delegated administrative responsibilities to other individuals or organizations as follows:

- Fund Office (Administrative Manager):
 - Maintains eligibility records
 - Accounts for employer and self-payment contributions
 - Processes certain claims
 - Administers the Death and Accidental Death and Dismemberment benefits
 - Answers inquiries
 - Handles routine administrative functions
- Medical Mutual of Ohio (MMO) provides access to a PPO network of preferred providers for medical care, performs prior authorization for certain medical services, and processes the medical claims.
- Sav-Rx administers the pharmacy network, mail order program and specialty pharmacy program for prescription drug benefits, and processes the prescription drug claims.
- Medical Mutual of Ohio (MMO) provides access to a PPO network of vision care providers through the EyeMed Insight Network. EyeMed processes the vision claims.
- Delta Dental Plan of Ohio provides access to the Delta Dental PPO network and Delta Dental Premier network and processes the dental claims.
